The unique ability of silicon photonics to bring electronics and photonics together on the same chip is poised to have a huge impact in optical communications and sensors for the internet-of-things. Indeed, silicon photonic **transceivers for datacenters** are already shipping in the millions, there is a growing market for silicon photonics based **coherent long-haul communications**, as well as ultra-compact silicon **biosensors for diagnostics**, and **integrated LIDAR solutions** are being explored. At the same time, research activity in this field continues surging, in the quest for faster and more energy efficient chips. Both industrial players as well as research groups from around the globe are active in this field and have produced more than a million papers on the subject.

Each year, “Group IV Photonics” brings together around **150 of the world’s leading experts from academia and industry** for three days to discuss their latest findings. The conference features two plenary talks, high profile invited presentations, an **industry special session**, as well as selected contributed talks and posters. Companies display their products in an exhibition around the electro-photonic production chain, including simulation and layout software, photonic design houses, foundries for fabrication, opto-mechanics, laser sources, imaging, and opto-electronics for testing.
